# MAYOR'S ADVISORY COMMITTEE FOR PARKS, TRAILS, AND URBAN FOREST, CITY HALL, STORM LAKE, IOWA APRIL 15, 2021 5:30 P.M.

Chairman: Michael Porsch Mayor. Commission Members Present: Renato Jimenez, Howard Hatlelid, Mike Thompson and Breanna Horsey; Via Online: Gary Petersen, Mayra Lopez, and Michelle Smith.

Meeting called to order by Chairman Mayor Porsch at 5:30 pm.

**Minutes** – Moved by Committee Member Peterson to approve the minutes from the November 14, 2019, meeting. Seconded by Committee Member Horsey. Vote: All ayes. Motion carried.

**Updates** – Mayor updated the committee regarding the donation for a full cour basketball court at Seneca Street Park and Redigs donation of service to dig up the location for the area, mini pitch complex at Chautauqua Park., Russel Street Park, and Emerald Park tennis court lights. Also, updated the committee of the piece of equipment that the city invested on to clean the shoreline.

**Public Art** – Mayor updated the committee regarding the lighthouses and Chautauqua Park Backstop artwork will be displayed and asked to be seen. Committee was asked come up with any other locations that art work can be displayed. For example, at Valentina's Meat Market, Witter Gallery, or owners located around the public parking lots.

**Bike Path** – City Manager Navratil update the committee of the new path will be installed on the old railroad track as part of the new housing development with Kading Development. Also discussed from a public speaker was the bike trail and how to coordinate a bike trail around the lake. The committee was updated that current estimate cost to go through the creek for just construction cost would be 1.2m going through the wetland floodplain and with environmental studies which does not include engineering cost, permitting, and property acquisition. It was suggested that signage be placed along the trail for example the purpose of the rain gardens and indicate the continuation of the bike trail.

**Dredge Spoil Site** – City is currently in the process of selecting an engineering to conduct a feasibility study for the dredge spoil site across the street from the dredge spoil site. With that plan the DNR would need to review the plan for approval and then it would be considered for future development based on that plan.

Storm Lake Proud Week May 15-22- Mayor updated the committee with this years plan for Storm Lake Proud and asked if the committee had any suggested. Kiwanis club will be participating in various task during the week, Planters downtown are being adopted, community park clean up will be Saturday, ISG would be shellacking the wood carvings, downtown owners and city staff will be cleaning the downtown. Asked the

school system if they would like to participate with any cleanup project. BVU Diversity group has adopted Circle Park. Boys Scotts and property owners in the area would be adopting the Scott Park.

Dog Park – Land that was for the dog park the person has passed away and since then the property has been sold.

**BVU Clean-Up Event April 22** – Dates set.

**Next Goal for this Committee** – Committee Goal are to continue with a dog park, soccer, field, and wall art ideas through out the city.

Committee was formed for the public art - Volunteers were Michelle Smith and Mike Thompson.
